Unless otherwise announced by the Commingling Partner:

- Where the sum of winning units of betting is less than the Dividend Unit, the Dividend Pool will be declared as the Dividend and winning units of betting will receive their proportional share of the Dividend Pool. The balance of the Dividend Pool will be carried forward and added to the Subsequent Quinella Dividend Pool (or to Tabcorp's jackpot fund).

Trifecta

Unless otherwise announced by the Commingling Partner:

- Where the sum of winning units of betting is less than the Dividend Unit, the Dividend Pool will be declared as the Dividend and winning units of betting will receive their proportional share of the Dividend Pool. The balance of the Dividend Pool will be carried forward and added to the Subsequent Trifecta Dividend Pool (or to Tabcorp's jackpot fund).

First4

Unless otherwise announced by the Commingling Partner:

- Where the sum of winning units of betting is less than the Dividend Unit, the Dividend Pool will be declared as the Dividend and winning units of betting will receive their proportional share of the Dividend Pool. The balance of the Dividend Pool will be carried forward and added to the Subsequent First4 Dividend Pool (or to Tabcorp's jackpot fund).

Unless otherwise announced by the Commingling Partner:

- When there are 4, 5, and 6 Starters, as determined at the commencement of Betting, there will be two place dividends paid. Where scratchings reduce the field to less than 4 Starters, Place bets will be declared void; and
- When there are 7 or more Starters, as determined at the commencement of Betting, there will be three place dividends paid. Where scratchings reduce the field to less than 5 Starters, Place bets will be declared void.

Quinella

Unless otherwise announced by the Commingling Partner:

- Where scratchings reduce the field to less than 3 Starters, Quinella bets will be declared void

Hong Kong Jockey Club (Special International Racing)

Unless otherwise announced by the Commingling Partner:

- When there are 4, 5, and 6 Starters, as determined at the commencement of Betting, there will be two place dividends paid. Where scratchings reduce the field to less than 4 Starters, Place bets will be declared void.
- When there are 7 to 20 Starters, as determined at the commencement of Betting, there will be three place dividends paid. Where scratchings reduce the field to less than 5 Starters, Place bets will be declared void.
- When there are 21 or more Starters, as determined at the commencement of Betting, there will be four place dividends paid. Where scratchings reduce the field to less than 6 Starters, Place bets will be declared void.

Quinella

Unless otherwise announced by the Commingling Partner:

- Where scratchings reduce the field to less than 3 Starters, Quinella bets will be declared void

Unless otherwise announced by the Commingling Partner:

- When there are 8 to 15 Starters, as determined at the official scratching time, there will be three place dividends paid.
- When there are 16 or more Starters, as determined at the official scratching time, there will be four place dividends paid.

- When there are 4, 5, and 6 Starters, as determined at the commencement of the Race, there will be two place dividends paid; and
